## FISHING SAFARIS

### General Terms and Conditions:

- Fishing Safari Excursions from the boat are approx. 3 – 4 hours in duration.
- Minimum age for children accompanied by parents on Fishing Safaris Excursions is 4 years of age provided they have sole use of the boat.
- Children younger than 18 years of age require signed authorization from a parent / guardian
- All Fishing Safari Excursions from the boat are subject to a minimum of 2 guest and a maximum of 6 guests.
- All Guests to sign Fishing Safari Indemnity Forms.
- All Fishing Safaris Excursions to be conducted by a Licensed Professional River Guide or Boat Captain.
- As with all Wild Life and Outdoor Adventure Activities there is an inherent element of risk involved in Fishing Safaris on the Zambezi River due to crocodiles, hippo and elephant.
- Victoria Falls River Lodge Luxury Tented Suites and/or the Victoria Falls River Lodge Island Treehouse Suites will take every possible contingency to minimize risk, but as per the terms and conditions for Fishing Safaris, as spelt out in the Indemnity Form, the Management and the Employees of Victoria Falls River Lodge Luxury Tented Suites and/or the Victoria Falls River Lodge Island Treehouse Suites are not accountable for any loss of property or injury sustained while fishing on the Zambezi River.
- Departure times are seasonal and in consultation with Management

1. US \$27.00 rod fee per Angler per day.
2. Any lost or broken tackle for the Angler's account.
4. All tackle, bait, and boat costs to be supplied and covered by Victoria Falls River Lodge Luxury Tented Suites and/or the Victoria Falls River Lodge Island Treehouse Suites.
